[^1]This reporting format excludes capital project and debt service expenditures that totaled $\$ 13.0$ million. Contributions to endowments were approximately $\$ 986,000$. Contributions designated for building projects totaled $\$ 2.5$ million. All contribution amounts related to seating in venues are reported by sport. Any related expenditures beyond the operation of the seating area are reported as unallocated. MSU had 7 home football games during 2010-11. MSU had 8 teams and individuals from 7 other teams compete in NCAA championships. The football team participated in the Capital One Bowl.

MSU implemented a new financial system in January 2011. Some expenses that were previously allocated by sport were unable to be allocated for 2010-11.
